 - d) Storm water drainage issues:
 - i) Gahanna has formed a storm water utility
 - ii) Letter to residents requesting that all sump pump and gutters flow to the street was not sent. This will be presented at the annual meeting.
 - e) The Christmas storm did significant damage to trees which need to be cleaned up this spring.
