

**Founder's Ridger Homeowner's Association  
Minutes from Meeting of Officers and Trustees  
February 17, 2003 at Bill and Joyce Hague Residence**

- 1) **Bill Hague, President, called the meeting to order at 7:00 p.m.**
- 2) **Minutes of prior officer's meeting approved as presented (Pontzloff/Cooper)**
- 3) **Carol Foerst presented treasurer's report.**
  - a) **Income and Expenses appear to be on budget—there have been no unexpected expenses.**
  - b) **It was suggested that we report Escrow funds separate from operating funds. Carol will reformat the report as suggested.**
  - c) **Treasurer's report was approved. (Cooper/Schmitt)**
- 4) **Unfinished Business:**
  - a) **Activating Gates—our current goal is 4/1/03. Leroy will make 12 keys and distribute to all residents on Morgan Lane**
  - b) **Replacement of approximately 3 trees which needed to be removed—Trustees will develop a plan.**
  - c) **Cutting of underbrush on Founder's Ridge Drive—Americascope inadvertently removed plants which they agreed was their error. They will replace the plants in the spring.**
  - d) **Installation of Sidewalks—Bill will continue to work with the homeowners.**
- 5) **New Business:**
  - a) **Budget—Carol presented a tentative budget for FY 2003**
  - b) **Election of Officers for 2003—agreed this would be finalized at the next meeting**
  - c) **Purchase of Lots 50 and 52**
    - i) **Several options were discussed regarding these 2 front lots**
      - (1) **Do nothing**
      - (2) **Consider purchasing the lots by allocating the costs over all lots**

- (a) This would mean that each lot-owner needs to come up with \$1,357 – either financed over a specified period of time or immediately
- (b) It also means that annual revenue from dues will reduce annually by \$1,000
- (3) Consider purchasing the lots by selling a portion of the meadow
  - (a) Adjacent home owners need to be consulted--this will happen on 2/25/03. Lot-owners invited: Becks, Akers, Loetz, Schmitt, Oruch, Gallagher, Danzeisen.
- ii) Since George has a current buyer, we agreed that waiting until the annual meeting to make a decision would be too long.
  - (1) We Agreed that we would call a special meeting for 3/5/03 to present the decision to the association.
  - (2) We Agreed that we would try to have this meeting in lieu of the annual meeting.
  - (3) We requested that Bill Hague contact George Parker to see if he can give us a sketch about how the houses may look on these two lots.
  - (4) We also requested that Bill Hague see if George would give us a schematic for how a lot in the meadow may look.
- 6) Bill Hague and Mardene Kelley will prepare the agenda, make arrangements to have a special meeting and distribute the agenda.
- 7) Next meeting on 3/4/03 at 7:00 at Bill Hague residence.
