THIS DOCUMENT AMENDS, RESTATES, AND REPLACES IN ITS ENTIRETY THAT CERTAIN FOUNDERS RIDGE ADOPTION OF WORKING CAPITAL ASSESSMENT, RECORDED UNDER DOCUMENT NO. 2016-16002028, IN THE OFFICIAL PUBLIC RECORDS OF HAYS COUNTY, TEXAS.

Cross Reference to that certain <u>Declaration of Covenants</u>, <u>Conditions and Restrictions for Founder's Ridge</u>, recorded under Document No. 2016-16001751 Official Public Records of Hays County, Texas, as amended and modified from time to time.

FOUNDERS RIDGE AMENDED AND RESTATED ADOPTION OF WORKING CAPITAL ASSESSMENT

This Amended and Restated Adoption of Working Capital Assessment (the "Adoption of Working Capital") is made and executed by FOUNDERS RIDGE RESIDENTIAL COMMUNITY, INC., a Texas nonprofit corporation (the "Association"), and is as follows:

- **A.** The Association previously executed and recorded that certain Adoption of Working Capital Assessment, recorded under Document No. 2016-16002028, in the Official Public Records of Hays County, Texas.
- **B.** In accordance with *Section 7.04* of that certain <u>Declaration of Covenants, Conditions and Restrictions for Founders Ridge</u>, recorded as Document No. 2016-16001751, in the Official Public Records of Hays County, Texas, as amended (the "**Declaration**"), the Association's Board of Directors may adopt a Working Capital Assessment in such amount as may be determined in its discretion.
- C. The Association hereby desires to amend its prior Adoption of Working Capital Assessment.

NOW THEREFORE, the Adoption of Working Capital Assessment is hereby amended and restated as follows:

- 1. <u>Working Capital Assessment</u>. In accordance with *Section 7.04* of the Declaration, the Association adopts a working capital assessment in the amount of ONE THOUSAND TWO HUNDRED AND NO/100 DOLLARS (the "Working Capital Assessment"). The Working Capital Assessment applies to all Lots subject to the Declaration unless otherwise exempt pursuant to *Section 7.04* of the Declaration.
- 2. <u>Subject to Change</u>. The amount of the Working Capital Assessment designated hereunder is subject to change from time to time by the Association.
- **3.** <u>Capitalized Terms</u>. Capitalized terms used by not defined herein shall have the meanings ascribed to such terms in the Declaration.
