## FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

#### FOUNDERS RIDGE

This First Amendment to Declaration of Covenants, Conditions and Restrictions for Founders Ridge (this "Amendment") is made by TAYLOR MORRISON OF TEXAS INC., a Texas corporation (the "Declarant"), and is as follows:

#### RECITALS:

- A. Declarant previously executed and recorded that certain <u>Declaration of Covenants</u>, <u>Conditions and Restrictions for Founders Ridge</u>, recorded under Document No. 2016-16001751, Official Public Records of Hays County, Texas (the "**Declaration**").
- **B.** Pursuant to *Section 10.03* of the Declaration, the Declaration may be amended by Declarant acting alone and unilaterally.
- **C.** This Amendment is promulgated for the purposes of clarifying an ambiguity in *Section 11.04* of the Declaration. *Section 11.04* applies to both subdivision entry facilities and fencing, as set forth hereinbelow.

NOW THEREFORE, Declarant hereby amends and restates the Declaration as follows:

- 1. <u>Subdivision Entry and Fencing Easement</u>. *Section 11.04* of the Declaration is hereby deleted in its entirety and replaced as follows:
  - 11.04 Subdivision Entry and Fencing Easement. Declarant reserves for itself and the Association, an easement over and across the Property for the installation, maintenance, repair or replacement of certain subdivision entry facilities, walls and/or fencing which serves the Property. Declarant will have the right, from time to time, to Record a written notice which identifies the subdivision entry facilities and/or walls and fencing to which the easement reserved hereunder applies. Declarant may designate all or any portion of the subdivision entry facilities and/or walls and fencing as Common Area by Recorded written notice. The exercise of the easements reserved hereunder will not extend to permitting entry into any residence, nor will it unreasonably interfere with the use of any Lot or residence or Improvement constructed thereon.
- 2. <u>Miscellaneous</u>. Any capitalized terms used and not otherwise defined herein shall have the meanings set forth in the Declaration. Unless expressly amended by this
